## Types of Emergency Reproductive Health Kits

ERH Kits, consisting of 13 different types, are divided into three categories.

- Block 1 consists of six sub-kits for the support of a population of 10,000 people for 3 months.
- Block 2 consists of five sub-kits with supplies for 30,000 people for 3 months.
- Block 3 is to be used at the referral/surgical obstetric level and include two kits sufficient to support 150,000 people for 3 months.

As such, the 13 self-sufficient kits are prepared in order to respond to a variety of emergency situations. A number of the kits can be used at the community and primary health care level while others are designed for use only by qualified and trained health personnel.

## Who can order the ERH kits?

Reproductive Health Kits can be ordered by the following organizations: UNFPA country offices, other UN agencies, local and international NGO's, Governments and Donors.

## How long will it take to deliver the kits?

UNFPA provides essential stock of ERH Kits for urgent and emergency requests. In emergency situations the order will be dispatched and delivered to the destination within 1 to 2 weeks (via air shipment).\*

# ERH KITS OVERVIEW

**Block 1**  
Kits serving the needs of 10 000 people for 3 months

- **Kit 0** Administration/ training supplies
- **Kit 1** Condoms: Part 1 (male condoms) and Part B (female condoms)
- **Kit 2** Clean delivery, individual: Part A (for mother) and Part B (for attendants)
- **Kit 3** Post rape treatment
- **Kit 4** Oral and injectable contraception
- **Kit 5** Treatment of sexually transmitted infections

**Block 2**  
Kits serving the needs of 30 000 people for 3 months

- **Kit 6** Clinical delivery assistance (A and B)
- **Kit 7** Intrauterine devices
- **Kit 8** Management of miscarriage and complications related to abortion
- **Kit 9** Suture of tears (cervical and vaginal) and vaginal examination
- **Kit 10** Vacuum extraction delivery

**Block 3**  
Kits to be used at the referral/ surgical obstetric level serving the needs of 150 000 people for 3 months

- **Kit 11** Referral level kit for reproductive health (A and B)
- **Kit 12** Blood transfusion kit
